**County of Morris Certificates**

Each year various agencies of the County of Morris will require evidence of insurance from member towns of the Morris County Municipal JIF for reasons such as the following:

- Community Development Grant Programs
- Use of Morris County Facilities – such as the County Training Facility
- Operations performed by member towns under contract with the County of Morris

Enclosed is a revised Blanket Certificate for the current Fund Year that has been provided to the County of Morris on behalf of the member towns of the Morris County Municipal JIF. This blanket certificate will serve as evidence of insurance for any County agency that contract with a Morris County Municipal JIF member town. The County Risk Manager will inform all of the County agencies that no further certificates are required from our members. Should any County agency insist on evidence of insurance, the member town should provide them with a copy of this certificate.

Please advise your respective Recreation Department Director of this procedure to ensure that certificates of insurance are not unnecessarily issued.

**Blanket Certificate – Morris JIF Member Towns**

Enclosed is the updated Master Blanket Certificate for the period of January 1, 2020 to January 1, 2021. This certificate is evidence of insurance for general liability, auto liability, excess liability and workers compensation. The certificate is to be used when one member contracts with another member town each of the Morris County Municipal JIF. This eliminates the need for certificates to be issued each time two member towns contract with each other. This certificate is on file with the JIF Administrator and each member town.

Also enclosed is the suggested hold harmless wording for “use of facilities” and suggested hold harmless wording for “use of services.”

### **Verizon Certificate**

Each year Verizon will require evidence of insurance from member towns of the Morris County Municipal JIF for reasons such as the following:

- Installation and removal of decorative holiday lighting
- Hanging of banners

Enclosed is the revised Blanket Certificate for the current Fund Year that has been provided to Verizon, at a revised mailing address, on behalf of the member towns of the Morris County Municipal JIF. This certificate is to be used when any of the member towns are going to be hanging any holiday lighting or banners on any Verizon owned poles. This eliminates the need for certificates to be issued each time Verizon requires proof of insurance.

Please remind your respective towns of this procedure to ensure that certificates of insurance are not unnecessarily issued.

### **JCP&L Certificate**

Each year JCP&L will require evidence of insurance from member towns of the Morris County Municipal JIF for reasons such as the following:

- Installation and removal of decorative holiday lighting
- Hanging of banners

Enclosed is the revised Blanket Certificate for the current Fund Year that has been provided to JCP&L d/b/a GPU Energy on behalf of the member towns of the Morris County Municipal JIF. This certificate is to be used when any of the member towns are going to be hanging any holiday lighting or banners on any JCP&L owned poles. This eliminates the need for certificates to be issued each time JCP&L requires proof of insurance.

Please remind your respective towns of this procedure to ensure that certificates of insurance are not unnecessarily issued.

### **Service Electric Certificate**

Each year Service Electric Cable Company will require evidence of insurance from member towns of the Morris County Municipal JIF for reasons such as the following:

- Installation and removal of decorative holiday lighting
- Hanging of banners

Enclosed is the revised Blanket Certificate for the current Fund Year that has

been provided to Service Electric Cable Company on behalf of the member towns of the Morris County Municipal JIF. This certificate is to be used when any of the member towns are going to be hanging any holiday lighting or banners on any Service Electric Cable Company owned poles. This eliminates the need for certificates to be issued each time Service Electric Cable Company requires proof of insurance.

Please remind your respective towns of this procedure to ensure that certificates of insurance are not unnecessarily issued.

### **Military Affairs Certificate**

Each year the State of New Jersey, Dept. of Military and Veterans Affairs will require evidence of insurance from member towns of the Morris County Municipal JIF for reasons such as Service Contracts for sewer and water requirements

Enclosed is the Blanket Certificate for the current Fund Year that has been provided to the State of New Jersey, Dept. of Military and Veterans Affairs on behalf of the member towns of the Morris County Municipal JIF. This eliminates the need for certificates to be issued each time State of New Jersey, Dept. of Military and Veterans Affairs requires proof of insurance.

Please remind your respective towns of this procedure to ensure that certificates of insurance are not unnecessarily issued.
